This contract shall come into force once any payment arrears for this point of supply have been settled by Sudstrom S.à r.l. & Co S.e.c.s. or any contractual links with other electricity suppliers (e.g. fixed term contract).

Please note that the installments collected are estimated on the basis of consumption for the previous/estimated period. The amount of the installments can also be validated by mutual agreement with the customer.

It should be noted that any electricity consumption recorded at the supply point as indicated above shall be charged to the contracting party, until the supply point is disconnected (or cut off) upon the initiative of the Contracting Party or taken over by another Contracting Party. If, for any reason whatsoever, the Contracting Party no longer intends to make use of the supply point (e.g. due to a relocation), it is the latter's responsibility to inform SUDSTROOM of this in writing, otherwise any future electricity consumption shall be charged to said Contracting Party until Sudstrom is notified thereof in writing. The Contracting Party is not released from its obligation by the simple transfer of residence to another address. The undersigned declares himself/herself as jointly and severally liable with the holder of this contract until formal release is granted by Sudstrom S.à r.l. & Co S.e.c.s. In the event of any discrepancy between different languages of these Terms and Conditions, the French version shall prevail.
